When the RENASYS EDGE pump is prepared for a new patient the following maintenance activities must be performed (please refer to user manual for full details and precautions):

#### **Cleaning and disinfecting**



- Turn Off the pump and disconnect from the AC power before cleaning and disinfecting to prevent electrical shock. Remove connected canister
- Wipe down the surface with a dampened cloth or disposable wipe. Warm soapy water or a neutral pH7 based detergent/ disinfectant or antimicrobial agent that is safe for use with plastics may be used.
- Visually inspect the surface for debris or soils that have not been removed and repeat cleaning steps if necessary

After cleaning, **disinfect** using these recommended pre-saturated wipes:

- Accelerated Hydrogen
  Peroxide
- Potassium Hydroxide
- Sodium Hypochlorite (bleach
- Quaternary Ammonium Chlorides
- 70% Iso-Propyl Alcohol
- Phenols

Following disinfection, wipe down the pump with a damp cloth to remove residual chemical residues.

#### Perform the pump Self-Test

After disinfecting, perform the pump Self-Test. Self-test functionality in between patient use is designed to help ensure confidence with device performance.
